He is Coach to 'Lethal' Leisel Jones, Beijing Olympic Champion & World record holder in the 100m Breaststroke (1:05.09) and also now coaches Great Britain's Ellen Gandy. Rohan has been an important member of Australian Swim Teams for many years including the 2008 Beijing Olympic Team. He coaches the high performance squad at Nunawading and also oversees the talent identification and coach development programmes at the club.
