Risk Evaluation

Due to the ongoing COVID-19 pandemic, and the plan of a Level 4 Competition on Saturday 19th June 2021, an additional risk assessment to the normal operational risk assessment is needed. This should be monitored by the Stafford Apex Swimming Club COVID-19 Lead; Emma Hawley.

Each work activity should have an existing associated risk assessment. That assessment should be examined whilst completing the COVID-19 risk assessment to reduce the risk of transfer of the virus. A decision should be recorded when additional action is required and when it is taken. This should be as specific as possible.

The assessment should be regularly reviewed by the COVID-19 lead and will need a complete review if the guidelines change from the Government and/or Swim England (Governing Body). The staff member should report any difficulties in either complying with the assessment or completing work between these reviews.

If there is any difficulty in reaching agreement on appropriate control measures the Club's Officers should be consulted as soon as any issues arise.

A copy of the individual assessment should be given to every person in control of the sessions.
